She will attend grocery shopping with the provider and potentially the father as well. SR will encourage both parents to attend on Sundays for grocery shopping and any other time needed.</p> <p>Pat. Aunt provides parenting and medical services on Sunday. The aunt will arrive at home at 8 AM for breakfast and check glucose. The aunt will grocery shop using the family funds, SNAP debit and Pick n Save gift cards provided by agency. SR will demonstrate how to budget for diabetes friendly options. She will encourage parents to come along. The aunt will purchase dietician approved foods for dinner. The Aunt and parents can bring along the food choice lists and recipes located in the health binder.</p> <p>REVISED: The aunt will ensure all the dad's snacks are not located in the kitchen cupboard but instead taken to the box in the parent's bedroom</p>
