# **Spaced Ed Curriculum 2025:**

Child Welfare and Domestic Violence Discussion Guide

### Suggestions for how to use this guide:

This guide was created to help continue discussions around the questions and practice related to domestic violence. The questions are open ended, meant to assist child welfare professionals to reflect on practice, spark discussion, and create an opportunity to review standards and other resources provided. Consider using this guide to engage in additional conversations with your colleagues, in team meetings or even larger group settings. We encourage you to use the questions and resources below in a way that works best for you and your team.

### **Discussion Questions:**

- 1. When working with a family impacted by domestic violence, what questions do you ask to understand whether the reported allegations constitute a concern for the safety of the child? Questions to consider may be:
  - Tell me about any recent injuries or accidents.
  - Where were the children during the abuse and what do the children do during the abuse?
- 2. Racial and cultural differences in how individuals experience, explain, or justify domestic abuse challenge CPS professionals to become aware of their own culturally based assumptions/bias about domestic abuse.
  - How do you check your bias and understanding when working with a family whose culture, values, and beliefs are different than yours?
  - We are all susceptible to culturally based assumptions or bias when working with diverse families. To learn more about the types of bias seen in Child Welfare, reference: Types of Bias in Child Welfare
- 3. Reflect on some examples of planning with families where domestic violence is/was present. Do planning statements (i.e., statements in either a protective plan or safety plan) require the survivor parent to control the behaviors of the harm doer? What language would you keep? What language would you change?

4. How have you collaborated with law enforcement and with domestic violence agencies and professionals in your community? What opportunities could there be for additional collaboration?
